Summary of Position:

The job of Mechanic was established for the purpose/s of ensuring the safe operating condition of all processing equipment includes determining needed repairs and/or replacements; performing required repairs, preventive maintenance and providing written documentation of repairs to meet facility, state and federal requirements.

Essential Duties for all Employees:

- Maintain a clean and safe work environment that promotes work safety and product integrity.
- Must follow all Safety, HACCP & GMP requirements at all times.
- Adaptable to a fast paced environment.
- Willing to be flexible to accommodate changing business conditions.
- Ensure cleanliness around facility, freezer and production area.

Job Specific Duties & Responsibilities:

1. Create and complete all assigned preventive and corrective work orders. Provide accurate documentation information for daily forms to audit inspection standards.
2. Provides emergency/unscheduled repairs of production equipment during production and performs scheduled maintenance repairs of production equipment during machine service times.
3. Prepares and sets up machinery for scheduled production runs. Supports sanitation by disassembling and reassembling of machinery before and after sanitation.
 - a. Chutes, Screens, Belts, Hoses, Covers, Chain, Knives
4. Performs intermediate mechanical skills including, but not limited to, mechanical, electrical, and hydraulic troubleshooting and repair of packaging and production machines. (Repairs and maintains, in accordance with diagrams, sketches, operation manuals, and manufacturer's specifications, machinery and mechanical equipment, such as engines, motors, conveyor systems, and production machines and equipment, using hand tools, power tools, and precision-measuring and testing instruments)
 - a. Based on evaluation and competency knowledge proven skills
5. Maintaining personal and company tools & equipment to BRC inspection compliance level.
6. Set up knowledge of equipment operation using Ignition System
7. Dismantles devices to gain access to and remove defective parts, using hoists, cranes, hand tools, and power tools.
8. Metal fabrication (Stainless Steel) Welding (TIG/ MIG) a plus but not required
9. Plumbing – Repair and new install (Schedule 80 PVC, Stainless steel, steel and galvanized pipe)
10. Metal Working a plus
 - a. Cutting, Grinding, Drilling, Punching, Metal bending
11. Lifting, Carrying, 50# lift min.
12. Obtain processing and related equipment knowledge of the facility departmental and equipment locations
13. Comply with all company GMP's, Policies, OSHA safety and health rules
14. Continued observation and learning of maintenance process / procedures of equipment operations, improving individual knowledge and skills of advanced work practices
